Developed and self-published four Bible studies addressing grief and infant loss from a Biblical perspective. These studies were used in Hope Group sessions, with 186 women participating in weekly 10-week Zoom-based groups that included teaching and small group discussion.

Podcast

Produced a biweekly podcast addressing grief, faith, and hope in Christ after loss. During the fiscal year, 34 episodes were released, totaling 8,583 downloads, with listeners in all 50 states and over 20 countries.

Gift of Hope Program

Provided financial assistance to families experiencing pregnancy and infant loss by paying qualifying medical bills directly to providers. During the fiscal year, 7 families were served, with total assistance of \$4,996.86.

Community Outreach & Ongoing Support

Provided ongoing Christ-centered encouragement and support to bereaved mothers through digital content, online community, and local chapter engagement. During the fiscal year, 78 blog posts offering Biblical encouragement and practical guidance were published, and a weekly email newsletter was distributed to over 5,000 subscribers. Social media platforms were updated daily, fostering consistent engagement and connection.

A private online community of over 6,000 members was supported through prayer posts, live and recorded teachings, and monthly Hope Baby Memorials, which included individualized digital images created to honor each baby. The organization's public social media presence grew to over 10,000 followers.

Additionally, 14 active Hope Mommies Chapters provided local, in-person support through Hope Box Gatherings and regular meetups, including worship nights, craft nights, dinners, playdates, and coffee gatherings, extending care and community to bereaved mothers and families within their geographic areas.

Observed Pregnancy and Infant Loss Awareness Month in October through awareness initiatives and resource distribution, including personalized memorial items such as candles and apparel to help families honor their babies and share their stories. Additional free resources were provided, including devotional content, worship gatherings, and speaking engagements, to encourage remembrance and point families to the hope of Christ.
